NALCAB supports local non-profit organizations that (a) focus on developing affordable housing and community facilities in low-and moderate-income communities, (b) support small businesses and neighborhood small business districts, and (c) provide consumer financial education. NALCAB's services for local non-profits include building core organizational capacity, supporting program development, and providing pre-development assistance for a wide range of affordable housing and economic development projects. In addition, NALCAB provides technical assistance to municipalities and states to effectively utilize funding they receive from US HUD under entitlement programs (CDBG, HOME and ESG) for community development, affordable housing and homelessness services.

4b (Code:) (Expenses \$ 2,692,271. including grants of \$ 2,692,271.) (Revenue \$)
NALCAB managed a portfolio of grants to local non-profit organizations in urban and rural communities to strengthen organizational capacity and support specific asset building projects that included consumer education, small business development, cooperative businesses and affordable housing development.

4c (Code:) (Expenses \$ 324,521. including grants of \$ 94,630.) (Revenue \$)
In 2015 NALCAB hosted a national conference for community development non-profits to address the needs and interests of asset building practitioners and aspiring leaders in the industry. Through these events as well as through online activities, NALCAB facilitates information sharing and peer-to-peer learning among non-profit practitioners. NALCAB completed its fifth class of Colegio Fellowship next generation leaders in asset building and community development. The fellowship prepares experienced asset-building practitioners to take on leadership roles within their organizations. NALCAB also provides internship opportunities for graduate students.
