the goal of building assets in low- and moderate-income households and under-served  
Latino communities. NALCAB'S capacity-building services focus in the areas of Equitable  
Neighborhood Development, Small Business Investment and Family Financial Capability.  
NALCAB implements this work through grant-making, technical assistance, and the  
facilitation of peer-to-peer collaboration. NALCAB also provides culturally-relevant  
training to community and economic development practitioners and engages next generation  
Latino leaders in the Pete Garcia Community Development Fellowship.
