Who We Are



MEMBERSHIP CRITERIA

NALCAB members are community-based nonprofit organizations, US Treasury designated CDFIs and/or community development credit unions that self-identify as being aligned with NALCAB's <u>mission</u>, <u>vision</u> and <u>core values</u>. Our members work on a local, state and regional level to advance economic mobility in Latino communities. Typically, NALCAB member organizations meet at least two of the following criteria:

- -A Latino/a in an executive leadership position (for example: CEO, COO, CFO)
- -Meaningful Latino/a representation on the Board of Directors
- -Serve a significant Latino or immigrant community
